LL.M. students earn their degree in Seton Hall Law School's hybrid weekend program. By scheduling in-class instruction on the weekend, students in the program have the freedom to structure weekdays as they please. (LL.M. students may also take some of their courses during the weekdays, if they prefer.) Courses are taught by the same talented professors who teach in the J.D. program. When not in the classroom, students in the LL.M. program engage with their professors and peers online.

Importantly, the LL.M. in American Law satisfies the requirements for eligibility to sit for many state bar examinations, including New York, exponentially increasing your job opportunities upon graduation.
